The WH budget couples the formula Byrne Justice Assistance Grant and JABG programs with competitive incentive grants that provide "bonus" funds to States and localities for better, evidence-based use of formula funds. The JABG grant should be considered in tandem with \$20 million for Juvenile Justice Realignment Incentive Grants, that will assist States pursuing evidence-based juvenile justice system alignment to foster better outcomes for young people, less costly use of incarceration, and increased public safety.
